Recently in July, we all received email from ANFP regarding CMS document posted on PROPOSED changes to the Long-Term Care CoP's Conditions of Participation/Medicare and Medicaid Programs Requirements for Long-Term Care Facilities. Included in the changes is the education requirement for Director of Food and Nutrition Services. As mentioned in the circular, the current rules are still in effect.
