The program committee will meet after the fall meeting and determine the dates of the next years meetings. The program committee will strictly be a committee to obtain and book speakers for both the Spring and Fall Meetings. The art of planning a quality meeting is to secure speakers many months in advance not only to promote the meeting early which will allow members to get the meeting on their schedule but to focus in on a diverse agenda that will meet all the members continued competency needs.

Hospitality Committee Proposal

The Hospitality Committee as we envision it, would be a smaller committee preferably with members who live in the central Indiana area where close proximity will be an advantage to make arrangements with the host hotel.

This committee would work in conjunction with both the Program Committee and Finance Committee to ensure the contractual arrangements and meeting set up arrangements are executed properly.

While it is always an advantage to have a consistent and easily accessible hotel to host state meetings, it is important for this

committee to always review proposals for a host hotel for the following year to ensure Indiana ANFP remains financially viable for the future.

This committee would also be responsible for selecting the menu, assist in obtaining door prizes and ensuring meeting arrangements the day of the hotel are properly staged. The committee would also work with the program committee to ensure speaker AV requirements are ordered.

This is an excellent opportunity for those members who have experience in planning past meetings to stay involved.





CDM Ethics By Tom Thaman, CDM, CFPP

As I have mentioned in the past, being a member of the Certifying Board for Dietary Managers has been one of the most rewarding volunteer experience in my 21 years as a CDM. I am really excited about the direction we will be going for future and hope to be able share and get feedback from my Indiana colleagues on some of our upcoming initiatives.

Beginning in June 2019, the Certifying Board will be requiring 1 CE of Ethics as a part of the 45 CE three year requirement for CDM's. By requiring 1 CE of Ethics we are modeling our standards after the Academy of Nutrition and Dietetics who also require 1 CE of Ethics for the RD.

ANFP at this time, is in the process of planning the necessary resources for all members to easily obtain this credit hour by either having a free CE in Edge or having a template 1 hour presentation for Chapters to present at meetings. More details on this will be published within the year.

I have been an advocate of requiring ethics for CDM's primarily because we do have a Code of Ethics we follow as CDM's but also to ensure that we monitor our profession by ensuring high ethical standards by our members.

For 20 years, I have worked for a public institution where our

employees are required to maintain ethical behavior to ensure that the public trust is maintained in our institution. For me, professional ethics is important.

We never want to profit off our job through vendors or contractual obligations that would create an unfair business advantage. Maintaining ethical behavior in hiring is also important and we do not discriminate against any individual on the basis of sex, religions, race or sexual orientation.

Maintaining proper ethical behavior is also important in maintaining privacy standards for our residents and patients as outlined in HIPPA regulations.

Ethics is vital in our organization to ensure that our finances are maintained and reported in an accurate man-

ner and that we as members report our Continuing Education in a proper and honest manner.

Finance Committee Proposal

One of the most important positions in any organization is the treasurer. Indiana ANFP has been very fortunate to have had Maggie Rowlands as our current treasurer. Maggie has not only done an excellent job of reporting our finances, she also keeps extremely accurate accounting records of our funds.

The Finance Team as proposed is designed to both assist Maggie in the reporting of chapter funds to the organization but also to serve as a training opportunity for Maggie's eventual successor in the role. The finance committee will be responsible for

budgeting, reporting and advising the directions of funds through out the year. Members of the committee will also assist the treasurer in submitting the correct tax forms to the IRS each year and will assist the hospitality committee in obtaining raffle items for chapter meetings. The committee will also work closely with the national chapter to ensure financial policies are clearly followed. The committee will help with the collection of money and receipts at chapter meetings.

For the financial solvency of Indiana ANFP, one member should be designated as the eventual successor for the treasurer.

Indiana ANFP Gives Back!! 2018/2019

Each year, the National Organizations encourages state chapters to develop a Community Service Project. Creating a service project is a requirement to be considered for the 2019 Diamond Award from ANFP.

This year, our project will be Meals on Wheels of Indiana. Housed in downtown Indianapolis, Meals on Wheels serves about 2000 meals daily to many homebound seniors throughout central Indiana. Maintaining nutritional health is vital for everyone but especially for the elderly. Meals on Wheel has also undertaken a new role through a recent grant with the Indiana State Department of Health funded through the Ryan White Meals for Life serving frozen meals throughout the State of Indiana to people living with HIV and AIDS. 2500 frozen meals are prepared at Eskenazi Health and are transported to various sites through Meals on Wheels to address the nutritional needs of this population. A short presentation will be given at the annual business meeting in September on this program along with a presentation on the Food as

Medicine Project at the Spring Meeting.

For the fall meeting, we will ask all attending to please bring items for their pantry that is both needed for the Ryan White Meals for Life and the homebound seniors in Central Indiana. Please consider bringing in one of the following items:

Low sodium soup


