CALL TO ACTION

Medicaid funding in jeopardy: Please contact your Members of Congress

The future of Iowa's Medicaid funding for skilled nursing care faces its greatest threat in years. Congress is considering reforms that would further challenge our ability to provide quality care to Iowa's poorest elderly living in skilled nursing facilities. The proposed reforms could dramatically reduce funding to the states and eliminate supplemental funding mechanisms.

The current reform proposals - part of the Affordable Care Act repeal and replace - include Medicaid block grants or per capita caps. These, in part, eliminate the open-ended nature of the Medicaid program and instead provide states with a set amount of money each year. One proposal that passed the House last year, but stalled in the Senate would have eventually provided 30 percent less funding to states. We all know that we cannot take any more cuts, let alone one of such magnitude.

IHCA is asking every IHCA member to reach out to U.S. Senators Chuck Grassley and Joni Ernst and their U.S. House Representative on this issue. As a provider of care and services to low-income lowans, you know how important Medicaid is when caring of lowa's oldest and most frail individuals.

We need you to weigh in with your elected officials in Congress on the vast importance of this program to our efforts to provide quality care, with quality staff and resources, for the elderly lowans we serve. AHCA has also asked members across the country to reach out: AHCA/NCAL Begins Nationwide Medicaid Advocacy Effort.

The best way to get your message to your Members of Congress is to participate in AHCA's Care Advocacy Center's campaign. From the Preserve Medicaid campaign page, you can enter your ZIP code and send a message directly to your Members of Congress. Feel free

to personalize your message as much as possible with examples of how cuts to Medicaid would adversely affect your staff, residents, families served and local community.
