

Student Progression - Exam Eligibility



Exam Eligibility

- Students must Register for the exam and ANFP verifies if eligible
- Eligibility is determined by graduation date and certificate for pathway I students

Student Progression – Activate Credential



Activate

 Effective June 1, 2018 - All individuals must activate their credential within one year of passing the CDM, CFPP certification exam.

Activation Process

- Individuals who take the exam as ANFP members will automatically be upgraded to certified status, with initial certification fee waived one time, and must maintain their Professional membership in ANFP through the following May 31st.
- Non-ANFP members must pay the certification fee to become certified and therefore eligible to accrue continuing education hours.
- Those who do not activate will be required to re-test to be eligible for certified status.

Student Progression – Maintain Credential



Maintain

- Pay your certification maintenance fee (every year)
- Earn the required 45 hrs of CE every 3 years. Of the 45 continuing education hours, a minimum of 9 CE hours must focus on sanitation and food safety.
- Report your CE hours to the CBDM.
- Save all CE-related documentation for two three-year certification cycles.

- Advantages? Saves time, money and trees!



CMS Regulations

- The Certified Dietary Manager, Certified Food Protection Professional (CDM, CFPP) credential is now listed as the primary qualification for the Director of Food and Nutrition Services in the absence of a full-time dietitian.
- A representative from the Food and Nutrition Services department must be included on the Interdisciplinary Team (IDT). The CDM, CFPP is the only credential listed in addition to the Registered Dietitian Nutritionist that is qualified to participate as defined by scopes of practice. A scope of practice is a critical component in defining the role of any credentialed professional.
- Based on CMS data and current membership, ANFP projects a need for 11,200 more CDMs needed over the next 5 years
