Are You Ready to Take the Journey to Become a CDM, CFPP?

If you decided that a career as a dietary manager is for you, follow these steps to get started:

Step 1: Enroll in an ANFP-Approved Training Program

To locate an ANFP-Approved Training Program, visit the ANFP website <u>here</u>. You can find inperson and distance online training programs. Select the one that meets your educational and personal needs.

Step 2: Seek employment in the foodservice department of a long-term care or acute care facility

CDM, CFPPs who meet the competencies to work as managers, work in non-commercial (not-for-profit) settings. Registered Dietitian Nutritionists (RDNs) and Registered Diet Technicians (NDTRs) also work in these settings. These non-commercial settings (hospitals, long-term care facilities, prisons, schools, etc.) care for large populations of people who may have special dietary needs. Both CDM, CFPPs and RDNs or NDTRs will serve as mentors for you as you complete your competencies in your training program at your place of employment.

Step 3: Notify your ANFP Approved Program Director that you want to be an ANFP apprentice Your program director will contact your employment supervisor to determine next steps to enroll you in the program.

Step 4: Complete your ANFP-Approved Training Program requirements

You will complete 120 hours of classroom learning with your chosen school and 150 hours of supervised field experience in your place of employment. All competencies will be taught and observed for successful completion. Once these requirements are met, you will successfully graduate with a certificate in Dietary Management from an ANFP-Approved school.

Step 5: You are now eligible to take the CDM, CFPP Credentialing Exam

Step 6: Activate Your Credential

If you are an ANFP member and pass the exam, your credentials are automatically activated and you can use the CDM, CFPP after your name right away. If you are NOT an ANFP member, you have up to one year to activate your credential online with CBDM after you pass the exam. BUT WHY WAIT? Don't you want to use your new credentials right away?
