Government Affairs

The CMS comment period for the LTC Proposed rulemaking ended Sept. 16. ANFP had good support from its members and stakeholders, as well as other healthcare associations and communities, which ANFP encouraged to submit comments in support of the current requirements to maintain the standards of the CDM, CFPP credential. Please note that as CMS reviews and takes into account the over 1,500 comments it has received for this rulemaking, the current requirements for the director of food and nutrition services in LTC—including the CDM, CFPP credential—remain in effect. In fact, the regulatory process is such that CMS will likely take several months to formulate and issue its final rule, which means that we will probably not have final CMS language on new requirements for the director of food and nutrition services until late 2019 or early 2020. ANFP will keep everyone posted!



Government Affairs

ANFP is closely monitoring the July 2019 CMS proposed revisions to the qualifications required for a director of food and nutrition services (§ 483.60). As March 10 nothing has changed, and the proposed rule changes are in the Long-Term Action stage. The Centers for Medicare & Medicaid Services has announced the delay in the Mega Rule Phase 3 Nov. 2019 requirements. This pushes the effective No News Yet Regarding CDM Requirement in CMS Regs date to sometime near the end of the first quarter of 2020 (March/April) to allow time to train surveyors and make the needed changes to the Surveyor Guidance in Appendix PP. ANFP will keep everyone posted once we have official word from CMS. Please note: the requirements for staffing qualifications (§ 483.60) in LTC facilities for the CDM, CFPP credential (listed as first) remains in effect and is the rule.


