## **Continuing Competency versus Continuing Education**

## A Lifelong Journey By Thomas Thaman, CDM, CFPP

If you were a CDM, CFPP who began a new three year CE cycle on May 31st, you were asked to complete a competency self- assessment on-line to determine where there are opportunities for you as a CDM, CFPP to grow professionally. This assessment tool is part of phase one of two phases that will move the credential from a continuing education model to a continuing competency model. This self assessment tool will be available for the next three years at the beginning of the education cycle.

Continuing competency is a model is commonly used in most healthcare including licensures for nursing and registered dietitians and many more. A continuing competency model helps you guide your own career journey.

Continuing education allows the CDM, CFPP to meet or maintain knowledge on professional trends. Continuing education also meets certification on licensure requirements. Continuing education does not require planning. The thought process is usually to obtain the

CE's regardless to whether it is pertinent to the CDM, CFPP's job or not. However the CE hours are logged and allows the CDM, CFPP to maintain their credential.

A CDM, CFPP has five domains of competencies and all continuing education is built around one of those domains:

Nutrition, Foodservice, Personnel and Communication, Sanitation and Safety and Business Operations. All ANFP approved course work are categorized in three different competency levels with 3 being the most advanced.

When evaluating your continuing education log at the end of your three year cycle, was it effective and did you learn anything new or were you just glad to get your 45 hours in?

Continuing competency takes a different approach because it allows the CDM, CFPP to plan their own education journey based on their own specific needs or where they hope to see their career. IF a CDM, CFPP whose current role is managing the kitchen and reports to a Director or Manager may have the ultimate goal of managing the department. They may want to take courses related to business operations or personnel management. To continue to grow their clinical skills which would be beneficial to a department leader, nutrition courses would be ideal.

## **ANFP Government Affairs Update**



LATEST NEWS FROM THE ANFP GOVERNMENT AFFAIRS & POLITICAL ACTION COMMITTEES

Effective October 1, 2023, the Centers for Medicare & Medicaid Services (CMS) will no longer acknowledge Option E as qualification for Director of Food and Nutrition Services in Long Term Care Regulations 483.60

#### THE GOOD NEWS IS:

The CDM, CFPP remains listed as the first staffing qualification (Option A), and is the only one that has a defined Scope of Practice. Only professionals with a Scope of Practice (CDM, CFPPs, NDTRs, and RDNs) are able to participate in the care planning process/IDT process.

This is a tremendous asset to the Care Communities we serve, so let's be sure to advocate for our credentials and the value we bring to the table every day.

CMS State Operations Manual Appendix PP Guidance to Surveyors for Long Term Care Facilities (Rev. 211, 02-03-23) F-801

#### **ACCESS**

§483.60(a)(2) If a qualified dietitian or other clinically qualified nutrition professional is not employed full-time, the facility must designate a person to serve as the director of food and nutrition services.

(i) The director of food and nutrition services must at a minimum meet one of the following qualifications —

\*\*(A) A certified dietary manager; or (CDM, CFPP credentials)

- (B) A certified food service manager; or
- (C) Has similar national certification for food service management and safety from a national certifying body; or
- D) Has an associate's or higher degree in food service management or in hospitality, if the course study includes food service or restaurant management, from an accredited institution of higher learning; or
- \*(E) Has 2 or more years of experience in the position of director of food and nutrition services in a nursing facility setting and has completed a course of study in food safety and management, by no later than October 1, 2023, that includes topics integral to managing dietary operations including, but not limited to, foodborne illness, sanitation procedures, and food purchasing/receiving; and
- (ii) In States that have established standards for food service managers or dietary managers, meets State requirements for food service managers or dietary managers, and
- (iii) Receives frequently scheduled consultations from a qualified dietitian or other clinically qualified nutrition professional.
- \*Option E expired on October 1, 2023, so no longer will be an accepted qualifier.
- \*\*(A) CDM, CFPP is the only option with a defined Scope of Practice which qualifies credential holders to participate in the care planning process, which meets the requirement for a FNS representative; a valuable asset in Long Term Care!
