

The Importance of Mentoring

Last summer, I was blessed to receive a couple of "lifetime achievement" awards from a couple of organizations including the *Distinguished Service Award* from ANFP at the ACE meeting in Scottsdale Arizona. While I was extremely humbled by those honors, I could not have accepted those awards without acknowledging key people at various points in my career that guided and mentored me and most important instilled self confidence in myself to take on the many professional challenges that I faced over the years.

Mentoring is one of the most important things that we can do in our profession because it gives us the opportunity to shape the future by influencing future leaders.

I have had many wonderful mentors over the years. One of the most influential mentors I had was actually my first professional mentor. His name was Ron and he was a regional sales director of a Hotel Management Company. He hired me in 1979 about a year after I graduated from college. The company he worked for had several hotels in the Pittsburgh area and had openings for Catering Managers and Directors at the hotels to manage the banquets and meetings at the hotels in the area. What I liked about Ron and will be eternally grateful for was that he gave me a certain confidence in my abilities that sustained my for the next several decades. He hired me as a catering manager (which was the Directors Assistant) and within six months offered me a role of Director at one of the companies airport hotels. The catering department was not in great shape. The staffed lacked leadership and the





supervisory team needed to be overhauled and replaced. The employees also did not work as a team either and all the staff were on one team or the other team and both teams loved to undermine each other. After observing this for a couple of weeks, I whined to Ron that I didn't think I was ready for this. (I was only 24) and his response was "stop it, you're making me mad" and I said why and he said "If I didn't think you could do this job, I would not have put you into it" What a great word of encouragement that was and I proceeded to get the job done and became very successful in my role with the company. Eventually, they sent me to other hotels they had to train or retrain new Catering Directors.

Fast forward 20 years and I was fortunate to be hired at Lockefield Village at Wishard by Nicole Fields who was the administrator at Lockefield Village. Nicole was instrumental in my promotion to Director at Wishard in 2004. When she approached me on the opportunity, I once again was second guessing myself. Nicole simply stated "What are you hesitant about? You can do this!" I took the job and I did!

Mentoring is not difficult, it is looking at that person you want to mentor and make them the best that they can be. It could be that "inner drive" that they demonstrated when they interviewed for the job or their ability to handle a shift without supervision. You can also be a great mentor as a CDM preceptor. Mentoring is important for the future of our profession. Where would you be if not for a great mentor!!!

Starting with this current issue, Indiana ANFP Leaders will provide members with updates on CDM, CFPP Recognition.

This information is important for all CDM's as to the status of universal CDM, CFPP regulatory requirements. This update was published February 3, 2023 from ANFP

Craig Brightup Luncheon with Senator Bill Cassidy (R-LA)

The Political Action Committee voted on and approved to release PAC funds for ANFP's Washington Representative Craig Brightup to attend a luncheon for the re-election of Sen. Bill Cassidy (R-LA) that took place on February 1. This meeting laid the groundwork for the upcoming visit to Cassidy's office during Dr. Joyce Gilbert, PhD, RDN and Barbara Thomsen's February 26-28 "fly-in" on Capitol Hill and discussion about the Annual Conference & Expo (ACE) in New Orleans.

ANFP Plans Meetings in Washington, DC

ANFP President and CEO Dr. Joyce Gilbert, PhD, RDN, and Government Affairs Committee Chair Barbara Thomsen, CDM, CFPP, will be in Washington, DC, February 26-28 for meetings on Capitol Hill. The "fly-in" is to raise awareness of the ANFP Apprenticeship Program which is based on the CDM, CFPP credential and, after a two-year process, was approved by and registered with the U.S. Department of Labor in November 2022.

ANFP Washington Representative Craig Brightup is planning meetings with House and Senate members and/or staff including newly-elected Rep. Jen Kiggans (R-VA), who wants to take a lead role on LTC issues; Rep. Kelly Armstrong (R-ND) about the University of North Dakota's CDM, CFPP program; Sen. Bill Cassidy (R-LA) about ACE in New Orleans, particularly with Cassidy being named Ranking Member on the Senate Health Education Labor and Pensions (HELP) Committee; and Sen. Bernie Sanders (I-VT) who is Chairman of the HELP Committee.

The Call for Volunteers Campaign is Now Closed!

Thank you to each one who applied for an ANFP board or committee position through the Call for Volunteers Campaign. The Leadership Development Committee will review board nominees, and Committee Chairs will review committee nominees between February 9-14, and candidates will be contacted with next steps between February 20-24. The committee will conduct phone interviews with Board candidates March 13-14, slate recommendations will be announced to membership on March 16, and the Board will approve the slate in April.
