### CBDM Approves Volunteer Leadership Activities for CE

Earlier this year, the CBDM approved Volunteer Leadership as a qualifying activity for continuing education. An individual serving in a volunteer activity (in a leadership position such as a board member, Committee Chairperson etc.) for an organization and to which no compensation is required can now received CE Hours

Volunteer Leadership Activities Criteria

- A. Organization for which activities are contributed must related to the domain in the detailed content outline
   (Sanitation, Business, Communication.
   Business and Nutrition)
- B. The activity must be in a leadership level in a non compensated role.
- C. A maximum of two CE's per year with a total of six CE in a three-year recertification period
- D. CE will not be awarded until the date of service ends.



## Leadership



Verifiable Documentation

The following must be included when submitting CE for Volunteer Leadership Activities

- A. Dates of service to the organization
- B. Letter of verification from the organization (Board Chari, President etc.) verifying service and dates of the leadership role
- Position description for volunteer4 role which usually can be obtained in the organizations by-laws or polies and procedures
- D. Summary of purpose and evaluation by the leaders submitting the CE. This is a summary of what leadership qualities have been learned during the leadership role.
