## Public Policy Award

Elaine Deutchman, CDM CFPP



Elaine Deutchman, CDM, CFPP, FSD has been a CDM, CFPP, and a member of ANFP for 38 years. She has worked in healthcare facilities for 27 of those years as CDM, CFPP and was a preceptor for the University of North Dakota Dietary Manager Correspondence Course. Currently, Elaine is working at Windom Are Schools at Windom, MN, as the Food Service Director for the last 11 years, directing the food service departments at three school sites and two satellite service cafeterias.

More recently, Elaine was faced with the challenge of providing meals to children in their community through public school foodservice departments until the end of the school year, as mandated by the governor of Minnesota and USDA. She worked with team members at the Minnesota Department of Education to ensure all students were served healthy meals throughout the summer and past school year.

### **Renew your MDH Food Manager Certificate at the MN ANFP Fall Conference**

MN ANFP will be providing an opportunity for members to renew their MDH Food Manager Certificate (CFPM) by offering 4 hours of continuing education in food safety on Friday, October 15 at our fall conference. These hours will meet MDH requirements for renewal as well as provide sanitation hours required to maintain your CDM, CFPP credential. Please see the message below from MDH regarding the end of the grace period that had been allowed during the COVID emergency. You may complete the required renewal hours anytime within the 3 years your current certificate is valid. It is not necessary to wait until just before the certificate expires. The sessions will also be open to non-members such as foodservice employees who to renew their certificate. **In addition, there will be an opportunity to take the ServSafe exam on Friday afternoon once the sessions conclude. However, you must complete the ServSafe course online prior to the conference and provide proof of completion at the time of the exam. There will be an extra charge for the exam.**

### **Renewal Modification Ending for Certified Food Protection Manager (CFPM) Credential**

Minnesota Session Laws 2020, Chapter 74, Article 1, Section 13, allowed the Commissioner of Health to temporarily delay, waive, or modify Minnesota Rules, Chapter 4626, that governs the requirements for food and beverage service establishments. Effective March 13, 2020, one of these modifications allowed an additional six (6) months after expiration of the credential for CFPM renewal applicants to complete their four (4) hours of continuing education in food safety. With the peacetime emergency declaration ending July 1st, 2021, this renewal modification will end August 30th, 2021.



## What this means for CFPM renewal applicants with credentials expiring after August 30th, 2021

### Individuals with CFPM credentials expiring after August 30th, 2021, must:

1. Complete 4 hours of continuing education in food safety on or before the expiration of their credential.
2. Within six (6) months of expiration of their credential:
  - a. Submit a completed Food Manager Certification Renewal Application (<https://www.health.state.mn.us/communities/environment/food/docs/cfpm/cfmrenappnew.pdf>),
  - b. Application fee (\$35), and
  - c. Proof of continuing education to the Minnesota Department of Health (MDH).
