



Spot Light ~ Inspection Ready

Are you yourself, your staff, and your facility survey, inspection or evaluation ready?

Best option is to be prepared all of the time. Do you know the risk factors that contribute to a foodborne illness and do you have Active Managerial Control over your work site? There are 5 reasons why a foodborne illness occurs.

1. Food From Unsafe Sources
 - do you have an up to date log of all your vendors
2. Inadequate Cooking
 - Staff trained and possibly certified with knowledge of proper cooking Temperatures?
3. Improper Holding, hot or cold
 - Is your staff properly trained on cooling procedures?
4. Contaminated equipment
 - Do you have a sanitation procedure for your area, equipment, and needs? Do your staff have training and knowledge of how to clean?
5. Poor Personal Hygiene
 - Do you have expectations for staff to follow? Do you provide them with uniforms or offer cleaning of the uniforms?

Our industry segment is "Institutions" which is made up of Hospitals, Nursing Homes/Long-term Care and Elementary Schools. We serve what is considered Highly Susceptible Populations, who are at risk for foodborne illness due to being immunocompromised.

Recommendations for correcting current issues –

- Review the areas of Impact
- Practice safe Procedures – Best Practices or Standard Operating Procedures should be followed daily.
- Provide staff Training – Continue on-going training, keep staff updated and aware of new processes and procedures.
- Monitoring – Evaluate your staff, training processes and yourself to insure you are prepared.
- FDA Food Code – be knowledgeable of all requirements for your business.

Managerial Control are two essential items that when properly utilized can insure you are survey prepared. Be organized and detailed! Practice what you preach! Document, Document, Document! Run like you are inspected daily! Have a strong Safety Culture and have Active Managerial Control! **Good Luck!**

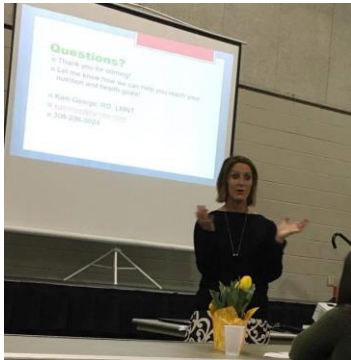
