Hello A.N.F.P. Wisconsin Members.

I wanted to share a few updates and Q & A on our upcoming A.N.F.P. Wisconsin Fall State Conference scheduled on September 17 and 18th 2020 in Onalaska, Wisconsin at the Stoney Creek Conference Center. As you are all aware, we are trying to identify our options as well as ensure the safety and health of all our Dietary managers throughout the state of Wisconsin, during this extended COVID virus period. As things begin to open up, you may have these questions, at the back of your mind, on our future state A.N.F.P. events.

1. Question: Will this Fall 2020 State Conference still be scheduled as planned?

Answer: Following C.D.C.., state and federal guidelines, as well as direction from nationals and from the conference center itself, we do not have a certain answer yet. However, In this time of uncertainty, we are doing our best to move ahead to continue to plan this event, as scheduled. Conference Center deposits have been put down, buses reserved for our outings, and contract signed for this event. We are reaching out to our speakers to ensure they are comfortable with being with a large group, are continuing to speak monthly with our hosting location (Stoney Creek) on if they are allowed to host our event per state guidelines and are receiving other planning options with Nationals if this event has to be offered in a different online format and how that occurs to receive CEU's.

Updates:

Currently Governor Schreiber, our keynote speaker, has suspended his speaking engagements, until further notice, pending further updates on COVID status in the state and recovery patterns. Due to the size of our meeting space reserved, Stoney Creek can provide increased distancing between seating tables and work with us on proving signeage for 6' distancing during meals and registration, if the state allows for larger groups over 50 to meet in one location (to be determined). We are reviewing with Nationals possible options of an online Zoom style conference meeting or teleconferencing, with our speakers remotely at an alternate location , with Q & A with our members, to receive CEU's. if it is not possible for us to meet in a larger group at our preferred meeting location, could our speakers present in a remote location online presentation? This is still in progress.

We are moving ahead with submitting those speakers that still would like to attend, if possible, with the assumption that this conference will be held, in our regular format, as scheduled. However, our state board is planning a contingency backup plan for a possible remote online format, if approved by Nationals, and working through how this would be coordinated and the technology needed to with seven speakers, and 80 - 100 Dietary Managers and the modified registration fee for CEU's for this event. Since hosting locations that provide comped or discounted conference room rental for large groups make up their profit by member sleeping room reservations, F & B revenues, and area retail revenue, many locations are hesitant to go ahead with these group events if it is not profitable, or based on the recommendations and mandatory restrictions by the state. As of right now, we are still on for this event with some modifications on social distancing and speaker changes if needed. As always, if any of our members have a small meeting location for a remote zoom teleconference location, that they would like to offer for no charge, as a last resort, for our board during these dates, please contact Rick at (414) 380-9640.

2. "I am concerned about not having enough CEU's for our renewal period, especially since our State Spring Conference was cancelled."

Answer: Our state A.N.F.P. board members have heard from many of you on your concerns that you may not have enough CEU's within your three year certification period to continue your credentialing. In last month's newsletter and again this month, you will find updates on the steps Nationals is doing to ensure that your certification required CEU's will not lapse by placing you into an audit period automatically instead of terminating your C.D.M. license due to non accrual of required CEU's. It is strongly recommended that you visit A.N.F.P. webpage to review current opportunities to receive online C.E.U.'s in Sanitation and Food Safety, Ethics (1 C.E.U. required) and other related topics to continue to earn C.E.U.'s in the interim. In addition, our vendors (Sysco, Reinhart, Martin Brothers and Indianhead Foods) are periodically offering C.E.U.'s on their websites for C.D.M.'s to receive online training inservices. These are generally free or low cost and great opportunities to pickup a C.E.U. each month to continue to grow your training and build your C.E.U.'s for your three year certification period. If you have additional concerns regarding this, please contact Marcia, Rick or any of our state members who can assist you with locating other CEU opportunities.

3.. "I have cabin fever from being at home or work all the time. What other upcoming events are scheduled or in planning for the next year?"

Destination state conferences are a new priority for our ANFP Wisconsin members to provide our members opportunities to travel to fun destinations and see other parts of the state and its area attractions, interesting historical, cultural, state parks, retail and tourist opportunities and enrichment activities planned by the board, during the two day conference. State President: Have a good understanding of the Volunteer Manual. You must also have a knowledge of all officer and committee positions and be willing to help other officers, committee chairs, understand their duties. Create the agenda for all executive board meetings and business meetings. Chair all meetings. Follow "Robert's Rules of Order" in conducting your meetings. Oversee activities of the Nominating Committee, Education Committee, and Spokesperson and Impact Committee. Train President-elect in your duties. Communicate with your membership through articles in your newsletters.

Forward all required information to DMA headquarters. Assign duties to each committee and officer to complete State Achievement Award

activities. Follow guidelines of the State Achievement Award and submit application by June 1. This is a two year.

<u>State President-Elect</u>: This is a two year term! Once you complete your term as President-elect, you automatically move to the position of President. Once this term is over, you move to the

position of Immediate Past President. Acquaint yourself with the responsibilities of the president. Review and understand the entire Volunteer Manual. Assume the duties of the president's office in the absence or disability of the president. Carry out activities assigned to you by the president. Attend all executive board meetings and all membership meetings. Make every effort to audit the National Board of Directors meeting held at DMA's annual meeting, in addition to any special meetings and workshops held for officers. As president-elect you are obligated to learn as much as possible about national & state goals, objectives, policies, and procedures. Serve as a member of the state Budget/Finance Committee. In the spring/summer before your year as president, appoint committee chairpersons and members. Send a written invitation to potential participants that will help explain the purpose and responsibilities of each committee. All appointments should be confirmed in

writing. Refer to your state bylaws to determine which committees you must appoint. The types of committee appointments will vary with each state, however, the following ones are routinely appointed:

- 1. Budget/Finance (often the treasurer is the chairperson)
- 2. Membership
- 3. Nominating
- 4. Education
- 5. Travel
- 6. Newsletter (one person is designated as editor)

In addition, your state may have other committees, such as historical and scholarship. This will depend upon the program of work that you and your executive board adopt. Two committees which the state president-elect must appoint are: Nominating Committee. .

<u>State Treasurer</u>: Keeps and reports the financial records of the State DMA Association. Serves a two year term.

State Secretary: Keeps and reports the minutes of the Board of Directors, General

Membership and any special meetings of the State DMA Association. Serves a two year term.

CE's from National

With the postponement of the policy that was to be effective June 1, 2020, individuals who do not meet the CE requirements by their May 31, 2020 deadline will be placed into the CE audit versus having their certification automatically terminated. On about June 1, an email notification will be sent to those individuals about being selected for the CE Audit and all required actions. (NOTE: Certificants who report the required CE and update all required documentation may also be randomly selected for the CE Audit.) When required actions are taken, selected individual will have until June 30, 2020, to show proof of meeting recertification requirements and could possibly be eligible for an extension to November 30, 2020 to meet recertification requirements. Once the audit process begins, they can work directly with their auditor to address questions regarding their CE record or other audit-related matters.

Also, please advise members that in-person education is not the only type of eligible CE activities. Please see the <u>CBDM Guide to Maintaining your CDM, CFPP Credential</u> for information about recertification requirements, including types of eligible CE activities, required documentation that must be uploaded, self-reporting and more.

You can also share that ANFP sends notices throughout the year about free CE available to members.

- Most recently, ANFP has made their Conference All Year Long webinar, Ethics 101: Discovering the CDM, CFPP Code of Ethics, FREE to all ANFP members through May 30, 2020. You can view the webinar <u>HERE</u>, along with instructions on how to access the free CE.
- A notice was also sent about how you can earn one general CE hour for each registered Benchmarking survey that is completed between March 1 – April 30, 2020. Access a video tutorial on how to register HERE.

ANFP has also made other various CE opportunities free to members. You can find these CE opportunities, as well as discounted CE, by visiting our <u>Discounted CE</u> page. You can also find CE in your area by visiting our <u>Find CE</u> webpage.

Individuals may also want to check ANFP Connect for programs that others share that are available from various sources.

Many facilities/companies offer in-service programs and webinars on issues related to the impact of COVID-19 on your facility, your residents/patients, staff responsibilities, etc. This is eligible type of CE when submitted and when required documentation is uploaded.
