

Take Hwy. 294 North to I-94. Follow I-94 to I-43 North in Milwaukee. Continue north on I-43 to Hwy. 57 North. Continue on Hwy. 57 to Hwy. 23 West. Turn right onto Hwy. 67 North, taking you into Elkhart Lake. Turn left at the four-way stop, then left on Osthoff Avenue.

From Madison:
Take Hwy. 151 North/East to Hwy. 23 East in Fond du Lac. Continue on Hwy. 23 East to Hwy. 67 North, taking you into Elkhart Lake. Turn left at the four-way stop, then left on Osthoff Avenue.

From Green Bay:
Take I-43 South to Hwy. 42. Turn right on Hwy. 42 and follow to Hwy. A in Howards Grove. Turn right on Hwy. A and follow into Elkhart Lake. Go straight at the four-way stop, then turn left on Osthoff Avenue.

ANFP Conference Registration Refund Policy:

Procedure for A.N.F.P. Wisconsin Refund of Registration at State Sponsored ANFP Conferences

Policy Wording:

To ensure fair and consistent practices to all our members, the following reimbursement of state conference procedures are implemented, effective 12/1/2019, by the A.N.F.P. State Treasurer.

All requests must be in writing (email or mail), to the state Treasurer, within seven days of the date of the conference. The request must include the members name, A.N.F.P. member certification number and copy of the registration form, payment method and amount of fee paid.

The request will be reviewed within three business days and notification will be via email. Members are required to provide a current address to receive check from the organization.

A 100% conference registration refund will be granted due to:

- ☐ A death of an immediate family member (parent, stepparent, spouse, grandchild, child, niece or nephew)
- ☐ Unexpected annual state survey visit in facility
- ☐ Serious illness to member, spouse or family member listed above, requiring hospitalization.
- ☐ Auto accident while traveling to conference limiting immediate transportation
- ☐ All other extenuating emergencies, as approved by the ANFP Wisconsin Executive Board.

The following situations will result in a 50% refund of conference registration:

1. Personal/Family Illness
2. Unexpected Scheduling Issue resulting in CDM to work shift.

Exclusions:

2. Inclement Weather: Changes in weather are **not** subject to registration reimbursement. Members are expected to review weather and travel conditions, prior to booking reservation and travel to ensure timely arrival and safe departure to the conference location. If the conference is cancelled due to a natural disaster or severe weather emergency resulting in damage to the hosting location or lodging site, all members will be informed of alternate location site or cancellation/refund policies for all registered members of registration fees.



Be sure to send me your photos from your events to include in the newsletter. Please include a short description. Deadline for the April newsletter is March 20th.




